Dear ENA-USA Members and the Efik Community At-Large,

It is with a sense of humility and relief that I inform all of you of the "Dismissal" of the lawsuit brought against our Corporation (**ENA-USA**) and several members of our leadership team by the Plaintiff, Mr. Asuquo Ukpong's group.

It is noteworthy to mention the background of this 14-month long lawsuit as an ugly reminder to all of us. The petition was initially filed on July 3, 2012, and included a sworn affidavit (signed & notarized) by Ete Augustus Edet to restrain the 2012 Efik National Convention in DC from taking place. When that effort failed and the convention was held successfully, the Plaintiff amended its petition on July 17, 2012 to "Prove Jurisdiction" with additional sworn affidavits (signed & notarized) from Ete Ekeng Henshaw, Mma Affiong Ekong and Ete Essien Cobham.

Few weeks ago, after consulting with the **ENA-USA** Executive Committee, I directed our Attorneys in Houston, Texas to file the Motions to dismiss the lawsuit. The oral arguments were heard on Monday, September 9, 2013 at 10 am before the presiding Judge in the 55th Judicial District, Harris County, Texas.

The Court ruled the following Monday, September 16, 2013, that:

The Plaintiff's live pleading, the Plaintiff's first Amended Petition and Application for Temporary Restraining Order, stated little if any basis for Personal Jurisdiction over the Defendants. Also, each of the Defendant's Motions rebutted all Jurisdictional Grounds, and each had gone unrebutted by the Plaintiff.

The Court granted the Defense's Motions, and the entire lawsuit was dismissed.
